- **Publication** of technical papers.

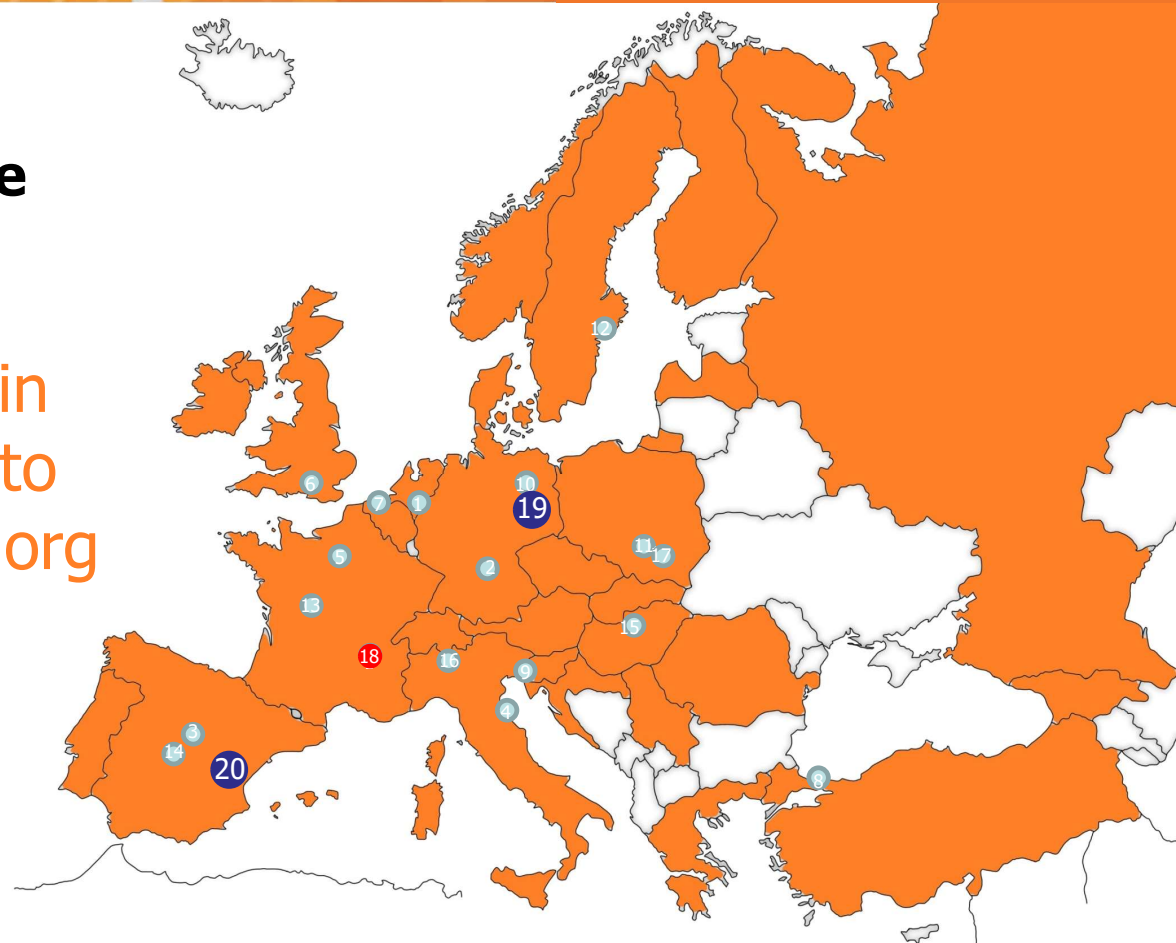

# Training/Summer Schools

For several years the European Ceramic Society has organized Summer Schools with the support of the JECS Trust: **15 Schools organised from 2015 to 2023**, mainly prior to conferences!

ECerS provides up to 12 grants every year to attend the **ACerS January Winter Workshop**.

The **ECerS Student Speech Contest** is held during the ECerS conference; young research students representing each of the ECerS member countries give an oral presentation that is evaluated by a jury

30 grants will be allowed to attend School/Conferences in USA and/or Asia in 2024

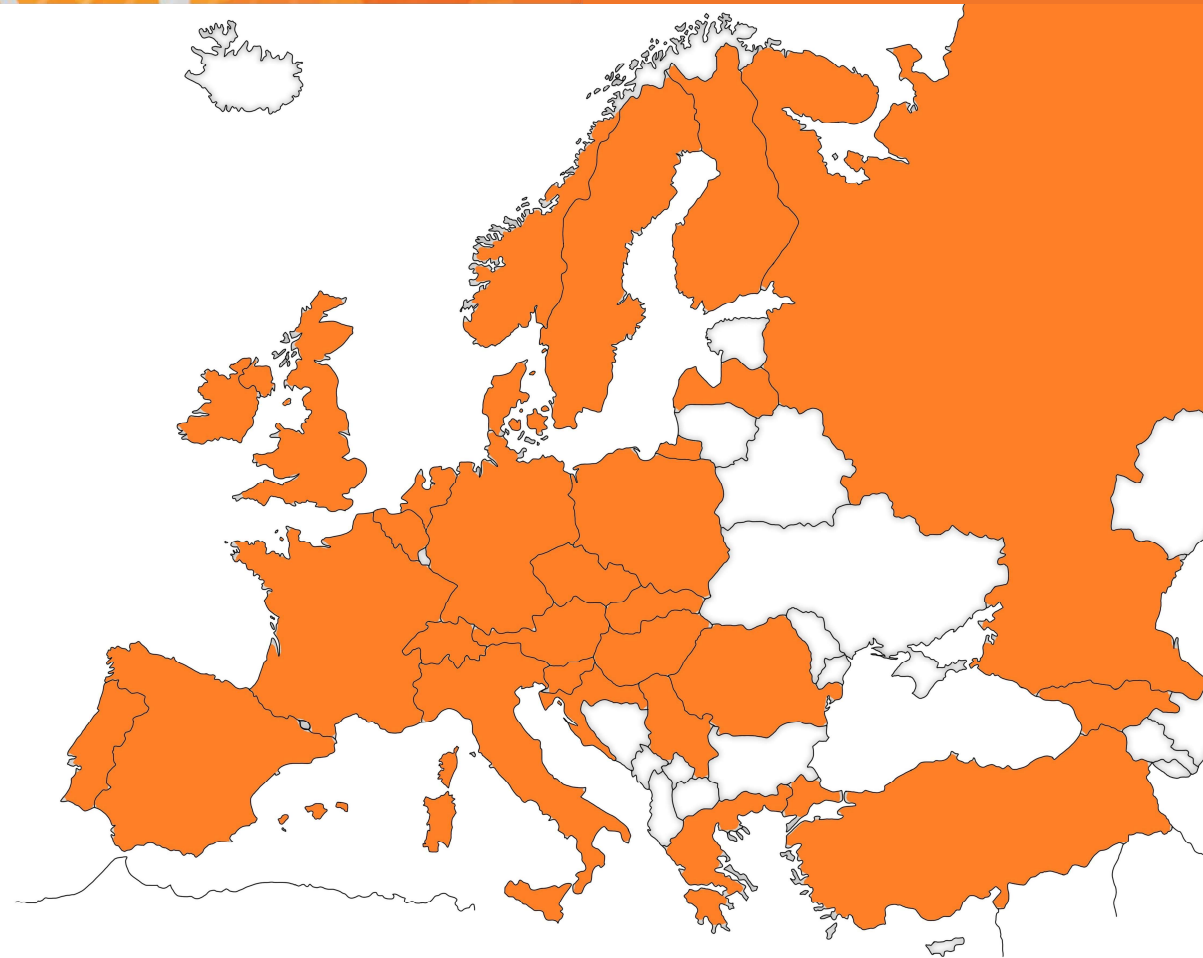

## Fund for European projects on ceramics

The JECS Trust was formally created in December 2007 to oversee the expenditure of funds passed on to the European Ceramic Society (ECerS) by the publisher of the Society's Journal, Elsevier.

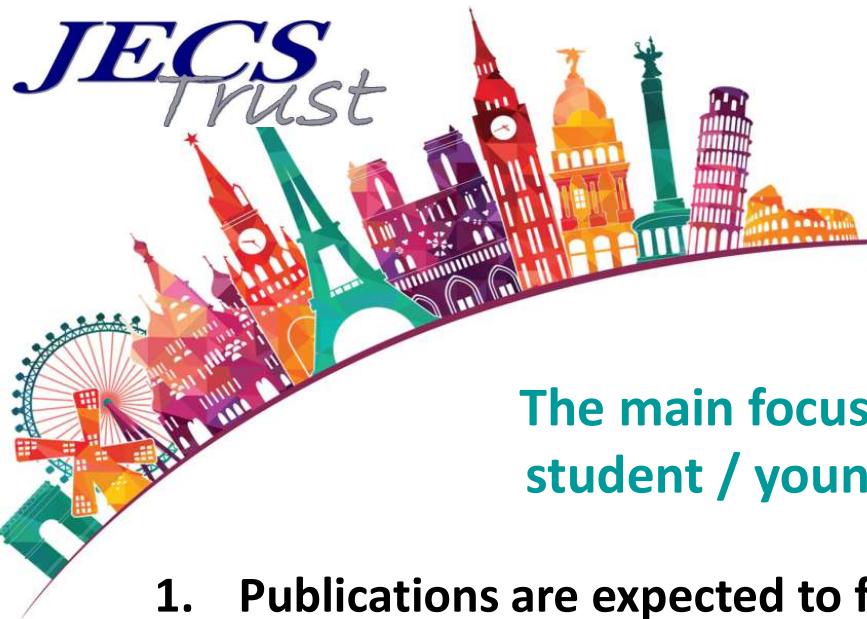
### In its allocation of the Trust's resources, the Trust Council aims :

- To enable the European Ceramic Societies to engage in a broad range of activities for the benefit of its membership.
- To strengthen research and teaching in Europe within the subject of ceramics
- To maintain and build on the current strong position of the Journal

**More than € 3 000 000 already awarded to 290 projects!**







## Some guidelines 1/3:

### Common for Mobility and General Activities:

The main focus in the expenditure of Trust money is towards student / young researcher activities, but not exclusively so.

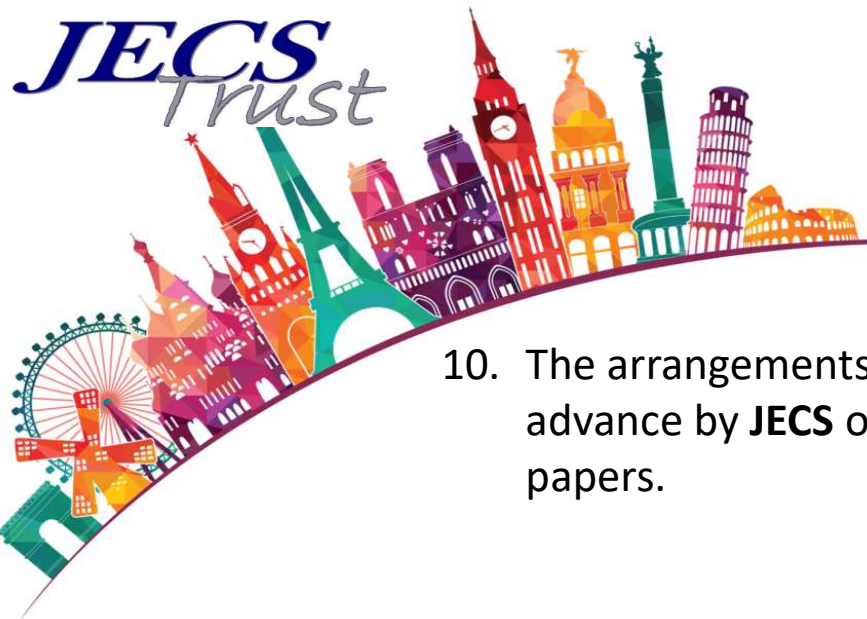
1. **Publications are expected to follow in JECS or in Open Ceramics** as appropriate.
2. Applicants must have been either members of a ceramic society affiliated to ECerS or direct members of ECerS **for at least 12 months**; *NB this rule is relaxed if the applicant is a student or young researcher, but he/she still has to be member.* If the applicant has a Supervisor then they must have been either member of a ceramic society affiliated to ECerS or individual member of ECerS for at least 12 months.
3. **The Trust does not accept proposals from individuals seeking support for attending conferences.**
4. The use of the JECS Trust money must be clearly identified in the application.



## Some guidelines 2/3:

### For General Activities:

5. JECS Trust money cannot be used to cover registration fees and/or meals, dinners, drinks, etc.
6. When travel expenses are allowed to Students/young researchers participating in an event sponsored by the JECS Trust, the amounts agreed by the JECS Trust are as follows:
  - 500 € maximum for travel and accommodation for international participants
  - 150 € maximum for travel and accommodation for local participants
7. The JECS Trust can provide promotional items on demand - so no funds are allowed for the following:
  - USB sticks
  - Notepads
  - Pens
  - Lanyards and badges
8. For conferences, workshops, etc., one representative of the JECS Trust board **could** attend the event for free to promote the JECS Trust and to check that the JECS Trust is well advertised (folders, logo on documents, etc.).
9. Any contest support by the JECS Trust must be called “JECS Trust contest” and any prizes awarded called “JECS Trust prizes”.



## Some guidelines 3/3:

### For General Activities:

10. The arrangements for any publication arising from the activity must be approved in advance by **JECS** or **Open Ceramics**, which **MUST** have the first option to publish the papers.

### Common for Mobility and General Activities:

11. Applicants wishing to receive financial support from the JECS Trust should submit their bids electronically to the JECS Trust secretariat;
12. Decisions on awards are taken by the JECS Trust Board; **decisions are final!**
13. Applicants must either be a member of a non-profit organisation (i.e. university, lab, etc.), an individual (i.e., not a commercial company) or the ECerS PEC.



## Favourable factors:

The Board of the Trust does not wish to be unduly prescriptive and applications of any kind that fall within the rules are welcome. However, the following list of factors are viewed favourably in ranking the proposals :

1. Activities involving collaboration between multiple members of ECerS (they must involve at least two ECerS full member countries or at least one ECerS full member and one associate member country);
2. Activities involving student / early stage researchers;
3. Applications for a clearly identifiable activity that can be specifically associated with JECS Trust funding;
4. The use of JECS Trust funding gives rise to a benefit that would not otherwise be possible;
5. Activities leading to **high quality** contributions to **JECS** or **Open Ceramics**;
6. Applications from regular contributors to the Journals;
7. Significant contributions from other sources, where appropriate to the activity.



## Examples of supported activities

### General Activities:

- **Events** such as workshops that are **specifically aimed at students / early stage researchers / high school teachers**
- **Activities coming from ECerS Working Groups** (after acceptance by the ECerS PEC)
- **Workshops on topical research areas**, put on either as part of the ECerS biennial conferences or at other times. For all such meetings, Elsevier would have a strong interest in considering the publication of a Special Issue of JECS or Open Ceramics containing high quality papers from the meeting.





## Examples of supported activities

### Mobility:

**Funding of visits by individual researchers to other laboratories** within Europe for the purposes of learning new techniques or accessing equipment not available in their own laboratories.

The stays can be from a few days to a few weeks, perhaps of 1 to 3 months or more, *if justified by the project*.

### **The grants awarded can include:**

- Travel expenses
- Per diem of €50 (for example, if the stay is of 30 days, then €1,500 is allowed)
- €500 per month for the host laboratory (for the use of facilities) *if justified*.



## How to submit an application

### Deadlines for the calls for projects :

- 28 February every year – MOBILITY ONLY CALL
- 31<sup>st</sup> May every year
- 31<sup>st</sup> August every year – MOBILITY ONLY CALL
- 30<sup>th</sup> November every year






